RESIDENTS ARE PROVIDED WITH A LIVING AND LEARNING ENVIRONMENT THAT ADDRESSES THE ISSUES OF ADDICTION IN A HOLISTIC WAY. THE PROGRAM'S CORE TENET IS THAT RECOVERY OCCURS IN RELATIONSHIPS WITH GOD, OTHERS, AND SELF. THE 12-MONTH DURATION OF THE RESIDENTIAL PROGRAM ALLOWS INDIVIDUALS SUFFICIENT TIME TO STABILIZE, REFLECT AND ADDRESS DEEPLY-INGRAINED BEHAVIORS, THINKING AND CONSEQUENCES OF YEARS OF ADDICTION. INTENSIVE CASE MANAGEMENT, INDIVIDUAL COUNSELING, GROUP FACILITATION, INDIVIDUALIZED EDUCATION AND VOCATIONAL TRAINING INCREASE THE LIKELIHOOD OF TREATMENT COMPLETION AND, ULTIMATELY, LONG-TERM RECOVERY.

SHELTER IS PROVIDED EVERY NIGHT FOR APPROXIMATELY 80 MEN AND 24 WOMEN. FOR THE YEAR ENDED SEPTEMBER 30, 2018, THE MISSION PROVIDED 40,766 MEALS AND 12,584 OVERNIGHT STAYS FOR THE HOMELESS OF SANTA BARBARA.
